**Location:** The George I. Huffman Memorial Range (Bayou Rifles) has 15 firing points at the 200, 300, 600 & 1000 yard lines. It is located approx. 25 miles south of Houston. Take TX Hwy. 288 south, cross TX Hwy 6, proceed 2.6 miles to Brazoria County Rd. 57 West. Turn right (west) and travel 1.8 miles. The range is on the right side (north) of the road.

**Schedule:** Sun Feb 25, 2007

Sat Nov 10, 2007

7:30 - Registration Closes  
7:45 - Pits Seal  
8:00 - Firing Begins  
Sighting – 5 shots – Any position  
Stage 1 - 200 yd slow fire prone 20 shots for record, 25 minutes (time includes sighters)  
Stage 2 - 200 yd rapid fire prone 1 ten-shot string, 70 seconds  
Stage 3 - 200 yd rapid fire sitting 1 ten-shot string, 60 seconds  
Stage 4 - 200 yd slow fire standing 10 shots for record, 10 minutes  
John C Garand Match Course B - Aggregate of stages 1-4

**Eligibility:** Open

**Entries:** Range Capacity is 60 shooters. Advance entries will be given preference. There will be no rain-delay dates for these matches. Pre-registration fees will be returned in the case of match cancellation. No-shows will forfeit entry fee. Registration closes at 7:30 AM the day of the match

**Challenge Fee:** A \$1.00 fee will be charged for any challenge. Fee will be refunded if challenge is won. Exact change is required.

**Rules:** Current CMP Competition Rules and NRA rules will govern. Competitors are responsible for the knowing the contents of the current CMP and NRA rule books. Competitors will score, work target pits and assist range personnel as required. No alibis will be allowed for rifle or ammo malfunctions.

**Sighters:** 5 Sighter shots will be allowed at the beginning of the match.

**Targets:** SR at 200 yards

**Squadding:** All matches will be squadded on the day of the match.

**Scoring:** Competitors will score. Any competitor failing to perform scoring duties may be disqualified.

**Rifles:** AS-ISSUED Garand, Springfield Rifles or M1 Carbine  
ACCURIZED Garand Rifles, Springfield Rifles or M1 Carbine (separate category)

**Ammunition:** AS ISSUED RIFLES - Ammo will be issued. Only issued ammo is approved for use.  
ACCURIZED RIFLES – Any safe ammo

**Chamber Flags:** An Empty Chamber Indicator (ECI) must be used. The rifle must be removed from the firing line with an ECI in place before the rifle is put into a case. ECI are available for purchase for \$1.00.
